### **Did you know? Christmas decorations can be a violation of the Ontario Fire Code**

Do you have a Christmas wreath on your front door? Well, if you live in an apartment building, that wreath, or any decorations festively left outside units, are a violation of the Ontario Fire Code.

Under the provincial legislation, flammables such as doormats, door decorations, wreaths, flowers, and more are prohibited in common area hallways of apartments.

“The fire service gets a bad rap when it comes to hallway decorations. We aren’t Scrooges. It’s actually based on tragic outcomes,” the fire department stated. “The Fire Code prohibits flammables (ie. doormats, door decorations, wreaths, flowers, etc.) in common area hallways of apartments, because, in case of fire, it would intensify the flames. Doormats should be placed inside the apartment entrance.”

A hallway is considered to be a “means of egress” (or exit) under the code.

### **Provincial government announces financial support, launches online application portal for parents**

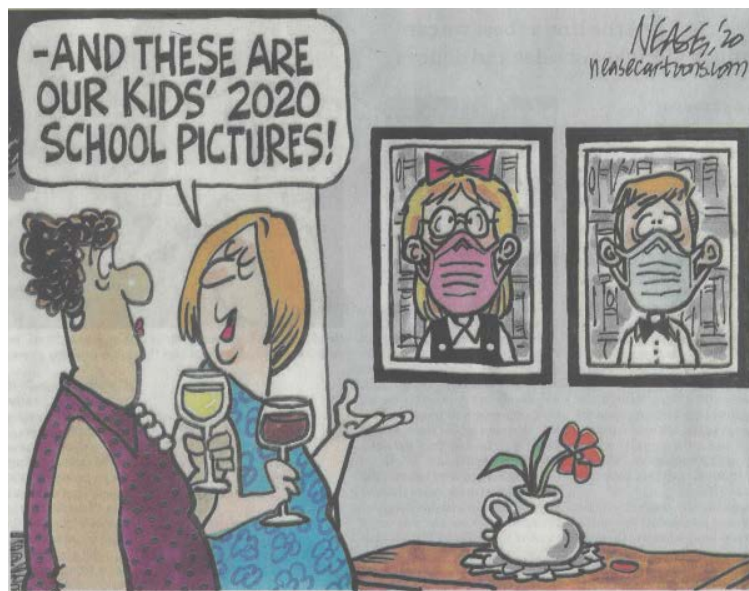
